

# Anderson Repeater Club, Inc.

May, 2025

Our regular meeting will be on Tuesday, May 6, 7PM in the EOC Training Room. Please plan to attend.

I hope that you have submitted your dues contribution for 2025, our 56<sup>th</sup> year as a club. Reminders have been sent out, and those who have contributed have had their membership certificate emailed to them. The membership list on the web site is current, so if you aren't listed please bring your dues to the meeting.

You may have seen that the ARRL Repeater Directory for 2025 is now available as a hard copy (\$19.95). They note that it is data from the Repeater Book web site ([www.repeaterbook.com](http://www.repeaterbook.com)). This is a free web site that requires only registration, and you must have an amateur or GMRS license (they beat it against the FCC database apparently). Anyway, if you don't need a hard copy go to the web site and register and you can search any number of ways for repeaters nationwide or worldwide (amateur or GMRS). For example, if you search for all repeaters within 25 miles of Anderson, IN it will list out 39 amateur systems. You can also search for coordinated repeaters in Indiana in a similar way at the Indiana Repeater Council web site ([www.ircinc.org](http://www.ircinc.org)). Repeater directories typically obtain information from the repeater councils. There are other web sites that list GMRS repeaters in a similar way.

A bit of Ham Trivia although not directly related to our club. Neil Rapp, WB9VPG, has been named the 2025 Hamvention Ham of the Year. Neil was born in 1970 in Vincennes, IN, and became WN9VPG at age 5, the youngest person in the world to pass an FCC Amateur License exam (Novice). At age 7 he passed the General (again the youngest) and at age 9 the Advanced (again the youngest). He got his Extra at age 20. Neil has been active in Indiana amateur radio and made lots of news when he became licensed. He has been a teacher over the years and has started a number of high school radio clubs. He is also active in a number of on-line amateur related endeavors. If you want to learn more about Neil, check out his QRZ.COM page, it's interesting and you can see his novice CW copied test page.... Looks like a 5-year-olds writing, but he got 114 characters in a row correct (only needed 25)! I guess you are never too young or too old to become an amateur.

Another bit of local ham trivia. Of the "alive" hams in Madison County:

- 1) Tom, W9EEL, was first licensed in 1953 as W0PQK (Technician), 73 years ago.
- 2) Frank, WA9JWL, was first licensed in 1957 as KN9VZN (Novice), 68 years ago.
- 3) Charlie, K9TZJ, was first licensed in 1959 as KN9TZJ (Novice), 66 years ago.
- 4) Steve, WA9CWE, was first licensed in 1962 as WN9CWE (Novice), 63 years ago.

Back in the day you could generally tell where a ham was located because your call was for the specific call district you lived in. If you moved to a different district you had to get a new call for that district. If you were operating mobile or portable in a different district you identified as "WA9CWE mobile 8" for example. In today's world of vanity calls there is no way to know for certain where a person is likely located.

Most of you probably know of the "Silent Key" plaque in the EOC. This is a long-term project of the County Club to recognize the passing of members of the two clubs. If you look at those calls and names listed, it represents the long history of amateur radio in our county and certainly a lot of RF talent. Thanks to Mike, KC9DJU, for his dedication to placing the new entries as needed.

You may have seen a flyer for the Auburn (Indiana) Hamfest on Saturday, July 19, 9AM to 2 PM. This is a nice hamfest and is located at the Auburn Cord Duesenberg Museum in downtown Auburn. Admission and parking are free as is admission to the museum on that day. If you have any interest in old cars in addition to radio stuff it is worth your time to drive up for the hamfest. In the event of a Central Indiana Skywarn net on the 146.97 repeater, the Welcome Net will be canceled for that evening. The Welcome Net - Indy will meet weekly at 8:00 pm Indianapolis time starting on Wednesday, April 16. The Welcome Net will continue to be a great place for new hams to get used to using their radios. While these nets are intended to help new hams, all amateurs, whether licensed 1 week or 20+ years, are welcome to check in. Welcome Nets are "conversational nets", where after initial check ins, a topic for discussion is posed by the net controller and then those that have checked in are encouraged to comment on the evening's topic.
